GIGACLEAR AGREEMENT TO INSTALL APPARATUS ON THE PLAYING FIELD: Butleigh Playing Field Association have agreed the locations of 2 cabinets. Clerk to sign the written network access agreement GWA- 125558/SW-BUTGH to install and maintain Electronic Communications Apparatus at the Baltonsborough Road Playing Fields as per map on behalf of the Parish Council. The total amount to be paid £1036.

CORRESPONDENCE: Avalon Care Home: Churchlake Care has run Avalon residential care home for approx. 1 year providing care and accommodation for 16 people however in February following storm Eunice, we found ourselves having to evacuate the home due to loss of services . We have now been working with the commissioners to identify what accommodation is needed in the area. Avalon Court will not change its registration but will accommodate six to seven customers with learning disabilities. Our customers will be supported by 24-hour care staff.
